Notification. You are hereby notified that a Request to Change the Language of ADR Proceeding (Request) has been filed in above referenced case pursuant to the Regulations (EC) No. 733/2002 and No. 874/2004 (the Regulations) and .eu Dispute Resolution Rules (Rules).

- (a) **Date Request Received and Time of Filing.** The Request submitted by *[Insert Complainant]* was received by e-mail on *[Insert date]* and in hardcopy on *[Insert date]* by the Czech Arbitration Court. - (b) **Deadlines.** Within 12 days from the delivery of this notification, you must submit to us a Response according to the requirements that are described in Rules, Paragraph A3 (b)(4) and in Supplemental Rules.
- (c) **Default.** If your Response is not sent in the period of time above, you will be considered in default. We will still appoint a Language Trial Panel (Panel) to review the facts of the Request and to decide the case. The Panel will not be required to consider a Response filed late, but will have the discretion to decide whether to do so and may draw such inferences from your default as it considers appropriate, as provided for by Rules, Paragraph B11. Other consequences are described in Rules and Supplemental Rules.
- (d) **The Panel.** The Request submitted by Complainant will be decided by a Panel consisting of one impartial and independent decision-maker [Paragraph A3 (b)(5) of Rules].
- (e) **Communications.** Your Response should be communicated to us according to the requirements of ADR Rules, Paragraph A3 (b)(4). For submitting your Response, use must use Form B6 available on the website of the Czech Arbitration Court and you must adhere to the communication instructions contained in the ADR Supplemental Rules.
- (f) **Fees.** In accordance with Rules, Paragraph A6 (b) and ADR Supplemental Rules, all fees concerning the Request have been paid by Complainant.
- (g) **The Language Trial.** After receipt of your Response or after the lapse of the time period for the submission thereof, we shall appoint the Panel.

You have the possibility of challenging the appointment of a Panelist and explain your reasons to us within 2 days from receiving the notice of the subject Panelist's appointment or after becoming aware of the circumstances giving rise to justifiable doubt in regard to the impartiality or independence of the

Panelist. In filing the challenge of appointment of Panelist, you must refer to the Form A21 available on the Czech Arbitration Court's website.

Notification of request to change the language of ADR proceeding and commencement of language trial

The Panel shall decide within 12 days from the date of its appointment. Under normal circumstances, we will forward the decision to you, the Complainant, and to EURid within three days of receiving it from the Panel.

The Panel decision shall be final and not subject to appeal.

- (h) **Case Administrator.** The Czech Arbitration Court has appointed a Case Administrator who is in charge of administering your request. Please note that, while the Case Administrator is at your disposal to answer questions relating to such matters as filing requirements and to help you to understand the Regulations, ADR Rules and ADR Supplemental Rules, he cannot provide you with legal advice or make any representations on your behalf.
